WASTEWATER TREATMENT PLANT

(OLOSARA STP SIGATOKA)

Purpose

The Water Fitter is responsible for carrying out all aspects of site sampling, monitoring and testing of all machinery and plumbing fixtures required to maintain compliance with relevant EMA regulations governing wastewater collection maintenance, repair and new installations. This position reports to the Technical Officer.

Principal Accountabilities

1. Fully compliant and operational Wastewater Management Operations assisted

- WAF Operational Standards, Environment Management Act, other governing standards and legislation are adhered to
- Thorough understanding and execution of Standard Operating Procedures (SOP) as well as quality standards ensured
- Technical Officer effectively and efficiently assisted in successfully delivering the following:
 - Maintains and repairs degrading structural and civil fittings in the collection system
 - Maintains equipment inventory and records.
 - Conducting routine checks wastewater collection systems and plumbing fixtures
 - Gathering material and installation tools.
 - Digging trenches using hand and machine trenching tools.
 - Locating installed piping systems
 - Removing old or broken piping systems.
 - Laying pipes into trenches or installing creek/river crossings and installing manholes inclusive of sewer connections
 - Checking pipe alignment and sealing pipes

- Sealing exposed pipe joints and fittings.
 - Filling and sealing pipe trenches.
 - Completes work order forms at completion of a call-out and submits to Technical Officer on a timely basis
 - Serves as the primary repair person
 - Performs vehicle inspections and maintains vehicle logs as per WAF policy
 - Engage in the simultaneous operations of CCTV unit, jetters and vacuum trucks
 - Work schedule and shift duties successfully delivered
 - Technical Officer effectively and efficiently assisted in successfully delivering the following:
 - All the scheduled PPM works on sewer collection systems to ensure that required service level quality is delivered at all times
 - All PPM and repair works carried out in accordance with SOP
 - Break down caused by delayed maintenance schedule or negligence eliminated
 - Customer complaints are rectified
 - Waste Water Management facilities kept neat and clean at all times
 - Full compliance with WAF's OHS and PPE requirements delivered
2. Timely, relevant and compliant reporting delivered
- All internal and external (if any) reporting requirements in relation to the outcomes of this role understood and correctly executed
 - Robust and relevant periodic reports/documents prepared and submitted as and when requested
