### About Our Organisation

### Position Objective

The Technician - Wastewater Treatment and Minor Schemes is responsible for assisting the Technical Officer Wastewater Treatment and Minor Schemes with the provision of sound advice relating to Wastewater processes and compliance requirements within WAF.

This responsibility includes facilitating and improving the provisioning of wastewater treatment across the region and network services across minor schemes in the region, supervising the treatment and safe discharge of effluent and bio solids, inspection, audit, verification and maintenance of wastewater treatment and network infrastructure in accordance with best practices.

The position reports to Technical Officer - Wastewater Treatment & Minor Schemes CE Region).

### Key Accountabilities

1. Effective and efficient plant process control provided for the WWTP.

- Assist in the maintenance of the Wastewater treatment plant systems in order to ensure discharge of clean treated wastewater.
- Conduct regular tests on and wastewater treatment processes against EMA parameters.
- Maintain the treatment plant system.
- Maintain and operate the treatment infrastructure and its processes units.

- Inspect, service and repair components of the Waste water treatment plant including water pipes, water storage tanks, Automated treatment equipment and controls, circulation pumps, and valves and report to Technical Officer.
- Ensure full treatment and discharge of wastewater to meet EMA regulated standard
- Inspect the treatment plant systems on a daily basis to ensure effective operations.
- Establish preventative maintenance schedules in consultation with the TO and Supervisor.
- Prepare activity and work reports and ensure records are maintained of the system.
- Report maintenance, servicing and repairs.
- Submit Weekly data to Technical Officer for the WWTP Dashboards
