As Fiji's water and wastewater services provider, WAF has a significant role in helping the Fiji Government achieve its vision for Fiji. Apart from the nine (9) focus areas, we will be also be focusing in improving system processes and effeiciency.

We will launch the first-ever National Water Sector Strategy 2050 Plan this year, a long-term plan that sets out the strategic objectives for the delivery of water services for the next three (3) decades. It will detail the current and future challenges which affect the provision of water services and the Strategy will focus its interaction with other national and regional strategic plans such as the National Development Plan.

WAF is committed to providing the best water & sanitation services to all Fijians. Our SCI reaffirms our commitment to engage with all our stakeholders to work together, so that we can meet the challenges of today and tomorrow.

2. Introduction

The Water Authority of Fiji (WAF) was established by the Government of Fiji in January 2010 to provide efficient and effective water and wastewater services to its customers and also setting up water supply systems in rural areas, giving access to water to Fijians to meet their daily needs. The Government of Fiji started reforming the Water and Sewerage Department (WSD) in 2009.

The objective of this reform was to enhance the sustainable delivery of water and wastewater services to appropriate levels of service. From January 1, 2010 WAF officially took over the responsibilities functions and operations previously carried out by WSD. The Statement of Corporate Intent is a requirement pursuant to Section 22 of the WAF Act 2007. The Statement of Corporate Intent states the activities and intentions of WAF for this financial year, together with a summary of the objectives, outline of the activities, projects which will be delivered, financial and non-financial targets, accounting policies, main elements as contained in our Corporate Plan.

6. Budget

The Fiji Government is committed to achieve a 24/7 provision of water and wastewater services, the Authority has been allocated a total budget of \$250.81 million: \$118.14 for Operational Expenditure and \$132.67 million for Capital expenditure.



This budget allocation is targeted towards the upgrading of WAF's existing water and wastewater infrastructures, to improve WAF's service sustainability through an efficient, safe and robust water supply system, improve sanitation to urban areas, increase service coverage, and to improve existing water & wastewater treatment capacity and process.
